

Agreement between Haj Group Organiser(HGO) and Haj Pilgrim for Haj 2019

THIS AGREEMENT is made and entered into at **BURHANPUR, MADHYA PRADESH** on **04-07-2019** BETWEEN **AL BURHAN TOURS AND TRAVELS** through **MOHAMMED WASIM, MOHAMMED ALTAF** and having their office at **SHOP NO 8/5 KHANKA MASJID COMPLEX SHANWARA ROAD BURHANPUR MP** Hereinafter referred to as the HGO

and

Mr. **MOHAMMAD WASIM** residing at **BERI MAIDAN NEAR ASGAR BHAI CHANDY LAZIZ HOTEL WALY** and holding Indian Passport No.: **H9303323** with Mobile No. **9893225590**, hereinafter referred as the PILGRIM

1. WHEREAS the HGO is a **Partnership** duly registered with the Haj Division of Ministry of Minority Affairs, Government of India vide **HGOID0058/MP03193619/CAT-I*/58/2019**.

2. WHEREAS the Ministry of Minority Affairs has allotted quota of **150** seats to the HGO for taking Haj Pilgrims to Saudi Arabia during Haj Season 2019 and on the strength of the said allotted quota, HGO has made arrangement for **BUDGET CLASS SHIFTING/SHIFTING, AL BURHAN AZIZIA/NON-SHIFTING** Haj Tour for the Haj pilgrims to be undertaken for Haj 2019.

3. WHEREAS the PILGRIM desires to perform Haj During 2019 and has approached the HGO and requested the HGO to include him/her in their Haj Pilgrimage Tour AND WHEREAS the HGO has agreed to include and take PILGRIM in his group for the Haj during Haj Season 2019 in **BUDGET CLASS SHIFTING/SHIFTING** for **36-42 Days** days on the following terms and conditions.

NOW THESE AGREEMENTS WITNESSED AND IT IS HEREBY AGREED BY AND BETWEEN THE PARTIES HERETO AS FOLLOWS:

It is hereby agreed by and between the parties that HGO shall provide the following services to the PILGRIM:

1. Air Travel

Air Ticket from **MUMBAI** to **JEDDHA** and return from **MADINAH** to **MUMBAI**

2. Medical Insurance / Group Insurance

The HGO shall take Insurance Policy of the PILGRIM inter-alia covering:

Medical Insurance: **NO**

Group Insurance: **YES**

3. Accommodation in Makkah, Madinah & Mina:

(a) Accommodation in Makkah in the Hotel / Building with basic necessary facilities (air conditioned rooms with lift facilities) in accordance with the following tour and package and shall pay the charges for the same.

4. Transportation Facilities:

The HGO shall provide local transport facilities in Saudi Arabia as below

- (i) Jeddah to Makkah- **Bus**
- (ii) Makkah to Mina- **Bus**
- (iii) Mina to Arafat- **Bus**
- (iv) Arafat to Muzdalifah- **Bus**
- (v) Muzdalifah to Mina- **Bus**
- (vi) Mina to Makkah- **Bus**
- (vii) Makkah to Madina- **Bus**
- (viii) Madina to Jeddah- **Bus**
- (ix) Jeddah to Airport- **Bus**

5. Duration of stay in Saudi Arabia:

The total duration of the stay of the Pilgrims in Kingdom of Saudi Arabia will be from **26-07-2019** to **11-09-2019** approximately **36-42 Days** details of stay in Saudi Arabia will be as below:

- 1. In Makkah from **26-07-2019** to **17-08-2019**
- 2. In Madina from **02-09-2019** to **11-09-2019**
- 3. In Makkah from **17-08-2019** to **02-09-2019**

6. Arrangements for providing orientation/ training programmes:

HGO shall arrange Orientation Programme for pilgrims wherein the HGO shall guide pilgrims about Haj procedures and Arkans as Islamic Sharia. In addition to the above, the HGO shall provide proper guidance and shall always be available with the group of pilgrims in Saudi Arabia to provide assistance to Hajjis as and when required. The HGO shall arrange for the orientation/ training of the PILGRIM on the date and place mentioned below:

Orientation/ training from **11-07-2019** to **11-07-2019**

Orientation Venue - **HUSAIN MARRAGE HALL HAMIDPURA HIGHWAY BURHANPUR M.P 450331**

Orientation Content - **HAJJ TRAINING CAMP**

All the services mentioned here in above shall be provided by the HGO to the PILGRIM for which the PILGRIM has agreed to pay to the HGO **Rs. 345000(three hundred forty five thousand)** by Cheque (s) /DD/RTGS and/or through their Bank accounts or other authorized channels duly notified by RBI from time to time. The HGO has acknowledged receipt of the amount and issued proper receipt (s) for

the said amount to the PILGRIM.

10. Additional Services:

a. For all the services mentioned here in below shall be provided by the HGO to the PILGRIM free of cost as part of the **BUDGET CLASS SHIFTING/SHIFTING Haj Package**

(BREAK FAST,LUNCH,DINNER,)

b. For all the services mentioned here in below shall be provided by the HGO to the PILGRIM for which the PILGRIM has agreed to pay to the HGO **Rs. 0(Zero)** by Cheque (s) /DD/RTGS and/or through their Bank accounts or other authorized channels duly notified by RBI.

- No Additional Services

11. Other facilities :

a. The HGO will provide assistance and help the Hajj Pilgrims during the 5 days of peak Haj and properly and correctly guide them to perform Haj Arkans.

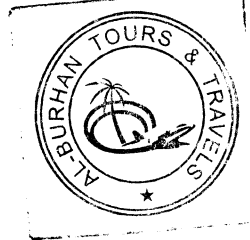
b. The HGO shall inform the Party of the Second Part about the compulsory vaccination and other medical checkup before their departure from India on getting information and its guidelines from the Haj Committee of India.

c. The HGO shall assist Hajjis regarding the medical facilities and shall provide information about the Indian Haj Mission Dispensary) Clinics and Medical Camps or Saudi Government medical Camps / Hospital at Makkah / Madina, where Hajjis can avail medicine and other medical facilities.
